## **Key Information**

The PhD student will join an international team of six researchers specializing in the sociology of emotions, social memory, post-socialist transformation, and deindustrialization. Working under the supervision of the project's Principal Investigator (PI), the student will play a key role in developing project metadata based on an existing collection of 130 biographical interviews. Their responsibilities will include analyzing these interviews, conducting additional ones, and transcribing them.

The position also involves contributing to literature reviews, writing project reports, and presenting findings at international academic conferences. The PhD student will coauthor peer-reviewed publications and actively participate in research team meetings and seminars organized by the Center for Research on Social Memory at the University of Warsaw.

Additionally, they will assist with organizational tasks such as planning workshops and scholarly meetings, as well as managing the project's website and social media presence.

### Applications are open to:

- 1. Current PhD students at Polish research institutions who are interested in an additional research scholarship (must be in their first year at the time of application).
- 2. Individuals seeking admission to the Doctoral School of Social Sciences (SDNS) at the University of Warsaw under an additional (research project) recruitment. After the recruitment process is completed, the candidate will be presented for approval to the School Board and the Director of SDNS. They will write their doctoral dissertation based on MEPOST project data, supervised by Prof. Joanna Wawrzyniak (University of Warsaw) and Dr Jogilė Ulinskaitė (Vilnius University). The University of Warsaw will provide a scholarship in the fourth year if the interim evaluation is positive.

## Requirements

- Master's degree in sociology, history, ethnology, cultural studies, or a related social science/humanities field.
- **Proficiency in Polish and English** sufficient for conducting and analyzing linguistically complex interviews and writing academic texts.
- Willingness to learn Lithuanian.

- Knowledge of qualitative research methods confirmed by the completion of relevant courses during studies.
- Genuine interest in the project
- Self-reliance and commitment to academic development.

### Welcome but not required

- Experience in conducting sociological qualitative research, including biographical interviews.
- Experience analyzing qualitative data.
- Familiarity with software for qualitative data analysis such as MAXQDA or ATLAS.ti.
- Proficiency in Lithuanian.
- Teamwork skills.

#### We offer

- **Participation in an experienced team** that values partnership-based relationships and professionalism.
- Opportunities for dissemination of project results through academic publications and workshops with practitioners (e.g., museum professionals, educators, and curators).
- Funds for participation in selected international conferences, workshops, and seminars.
- Mentorship and academic support.
- Involvement in academic life at the University of Warsaw, especially within the Center for Research on Social Memory and the Department of Economic Sociology and Public Affairs.

#### **Selection Process**

The process follows NCN guidelines for awarding scholarships in funded research projects (*Regulamin przyznawania stypendiów naukowych NCN w projektach badawczych finansowanych ze środków NCN. Załącznik do uchwały Rady NCN nr* 124/2022 z dnia 1 grudnia 2022 r.)

The recruitment is run by a committee chaired by the project PI and includes two other members with the necessary academic or professional qualifications. The process has two steps: reviewing applications and conducting interviews. The committee will proceed only complete applications and those that meet the requirements listed in this announcement.

### **Evaluation Criteria**

The scholarship committee reviews applications using a scoring system to rank the candidates. Applicants' academic accomplishments are evaluated based on a point scale:

- Academic achievements, including peer reviewed publications (50% of the final score): 4 points: outstanding, 3 points: very good, 2 points: good, 1 point: weak, 0 points: no academic achievements
- Research recognition, such as scholarships, awards, and academic experience
  gained locally and internationally, as well as participation in academic
  workshops, training, and research projects (20% of the final score): 4 points:
  exceptional, 3 points: significant, 2 points: moderate, 1 point: weak, 0 points: no
  achievements
- **Skills** for carrying out specific tasks within the research project (30% of the final score): 3 points: very good, 2 points: good, 1 point: weak, 0 points: no skills.

In the event that the selected candidate withdraws, the committee reserves the right to choose the next candidate from the ranking list. If no suitable candidates are available, the committee reserves the right to extend the application deadline or reopen the competition.

# Language of the interview

The interview will be conducted in English with some elements in Polish.

### **Scholarship**

#### Doctoral Students in SDNS:

PLN 5,000 gross monthly for the first 24 months and PLN 6,259 gross monthly for the next 24 months after a positive interim evaluation, with additional funding for international conferences and workshops.

## Current PhD Students in Other Institutions:

PLN 5,000 gross monthly for 36 months as an additional scholarship, with additional funding for international conferences and workshops.

The scholarship agreement may be terminated in the event of a lack of progress in the project.

## Required documents in a single PDF file in the following order

- Cover letter in English.
- CV in English including information on participation in research projects, scholarships, awards, academic workshops and training, and publications. The CV should also include PESEL number or passport number, information on citizenship, contact details (residential address, email address, phone number), a photograph of the candidate's face for identification purpos, contact information for one person willing to provide a reference upon request from the project PI (name, position, email).
- A PDF of the candidate's one best academic work: an academic publication, research report, or a paper written during studies, in either Polish or English.
- Scans of documents verifying the most significant academic activities listed in the CV (active links to publications or scans of the first pages are sufficient). The committee reserves the right to request additional materials from candidates.
- A statement confirming readiness to enroll in the Doctoral School of Social Sciences at the University of Warsaw (UW), or a statement confirming enrollment in a doctoral school in the first year of studies. If enrolled, the candidate should include the title of the research project they are working on and provide the name of their academic supervisor or advisor.
- Scanned Master's diploma.
- **Proof of English proficiency** (at least B2) or declaration of ability to pursue doctoral studies in English.
- Consent to receive administrative decisions via electronic means of communication
- **Consent to the processing of personal data** for the purposes of the recruitment process, according to the attached form
- A statement confirming familiarity with the content of Articles 40 and 41 of the Code of Administrative Procedure
